

### About Haven House Services and Second Round [2R]:

Haven House Services was established in 1973 as a non-profit organization dedicated to, and improving the quality of life for at-risk youth and their families. Haven House Services help struggling young people and their families develop positive and successful relationships at home, at school and in the community. We work with families, schools, government agencies, the courts and other organizations to help vulnerable kids find their way to a positive productive life. During 2010-2011 Haven House Services directly impacted more than 3,000 youth.



For the past six years, Second Round Boxing (2R) has been an integral part of Haven House Services' Gang Outreach Program. Endorsed by Raleigh Police Chief Harry Dolan, 2R promotes resiliency protective factors and positive youth development while reducing exposure to risk factors. 2R targets youthful offenders and gang-involved young men and women between 11 and 18 years old, and uses boxing, weight training, and other forms of exercise to teach teamwork, self-discipline, time management, leadership, healthy living, and other pro-socialization skills. While 2R has been built using boxing as a "hook" to get kids involved, you will see we are making core changes to make 2R a more comprehensive fitness, athletic and holistic wellness program. What will stay the same will be our continued commitment to evidence-based Positive Youth Development principles, and empowering our young people to work hard and be responsible for their positive outcomes.


